

**ASSUMPTION OF RISK, RELEASE AND WAIVER OF LIABILITY,
AND INDEMNITY AGREEMENT**

In consideration of and as a requisite to participating in the airsoft activities organized by North Texas Airsoft and Tactical Airsoft Combat, llc. (the "Activity"), the undersigned "Releasing Party" agrees to the following terms and conditions:

I acknowledge that but for my execution of this Agreement, I would be excluded from the field of play and not allowed to participate in the Activity. I accordingly enter into this Agreement of my own volition and without any inducement or assurances of any nature, fully aware of the hazards posed by the Activity and the rights surrendered through this Agreement.

I understand the nature of this Activity; I am qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I believe conditions are unsafe, I will immediately discontinue participating in the Activity. I further acknowledge receipt and/or review of the rules and regulations pertaining to the Activity, including the safety guidelines appertaining thereto, and agree to adhere to such rules and regulations, including without limitation the obligation to wear appropriate safety gear at all times.

I fully understand that this Activity involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "Released Parties" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for any and all injuries, losses, costs, and damages I might incur as a result of my participation in the Activity.

I hereby release, discharge, and covenant not to sue North Texas Airsoft, inclusive of its directors, agents, officers, volunteers, and employees; other participants in the Activity; the owners and/or lessors of the premises on which the Activity takes place; and if applicable, any sponsors and advertisers (the "RELEASED PARTIES," respectively) from all liability, injuries, claims, demands, losses, or damages I might sustain or incur through my participation in the Activity, whether caused in whole or in part by the negligence of the "Released Parties" or otherwise, and I further agree that if, despite this Release, I (or anyone acting on my behalf) make a claim against any of the Released Parties, I will defend, indemnify, save, and hold harmless each of the Released Parties from any losses, liabilities, damages, injuries, or associated costs (including attorney fees and associated litigation costs) incurred in connection with such claim(s).

This Agreement constitutes a complete and unconditional release of all liability to the greatest extent allowed by law. If any portion of this Agreement is held to be invalid, the balance shall continue in full force and effect. All disputes associated with my participation in the Activity and with this Agreement shall be resolved under the laws of and in the courts of the State of Texas, with venue thereof seated in Fort Worth, Tarrant County, Texas.
